## **2005 SWRHA Futurity Conditions**

## **GENERAL CONDITIONS**

- 1. Open to three year old horses of any breed.
- 2. Horse and rider MUST be nominated at time of entry.
- 3. Copies of competition license and NRHA membership cards for owner and rider MUST accompany entries.
- 4. Entries MUST be RECEIVED by October 14, 2005.
- 5. Nomination fees plus judge's fees must accompany entry forms.
- 6. Post entries accepted until 4:00pm October 26. A penalty of \$100.00 plus all regular entry fees will be charged for any entries received after October 14, 2005.
- ABSOLUTELY NO REFUNDS. Substitutions will be permitted with a \$50.00 penalty after October 14<sup>th</sup>.
- 8. For the Open, Int. Open, and Ltd. Open classes, there will be a first go and a finals. The number of horses taken back to the finals will be based on the NRHA placings per number entered (per NRHA payback schedule B) plus 5 additional entries. 35% of the purse will be paid in the go round, according to NRHA payback schedule B percentages and 65% of the purse will be paid in the finals, according to NRHA payback schedule B percentages.
- 9. For the Non Pro, Int. Non Pro, Ltd. Non Pro, and 50 and Over Non Pro classes, there will be a first go and a finals. The number of horses taken back to the finals will be based on the NRHA placings per number entered (per NRHA payback schedule B) plus 5 additional entries. 35% of the purse will be paid in the go round, according to NRHA payback schedule B percentages and 65% of the purse will be paid in the finals, according to NRHA payback schedule B percentages.
- 10. Discounts for the Futurity Classes For all Open classes, there will be a \$50.00 discount for each additional division entered. For all Non Pro classes, there will be a \$25.00 discount for each additional division entered. For all cross entries, there will be only one judges fee due. (Higher of the classes). Discounts apply to one horse/one rider entry.

## **GENERAL SHOW CONDITIONS**

- STALLS: Move in will be available no earlier than 1pm, Saturday, October 22nd <u>Stalls reserved</u> only with payment in full, due October 14<sup>th</sup>. ALL HORSES MUST HAVE A STALL OR DAY FEE. If you want to stall with someone, all fees and reservations <u>must be sent together</u>. If reservations and monies are not received by October 14<sup>th</sup>, limited stalls will be available on a firstcome, first-served basis. Shavings will be available. STALLS ARE LIMITED! Paid reservations are critical. See Stall Reservation Form for details.
- WARM UPS: Paid warm ups are available Sunday thru Tuesday. All futurity entries will receive one slot per horse and MUST be pre-paid with entry forms. <u>Absolutely no guarantees unless prepaid</u>. For all other warm up reservations, call Joan Quinn at 580-276-4501, between the hours of 8:00am and 7:00pm. Reservations accepted starting October 15<sup>th</sup>. All misc. warm ups must be paid within 5 days of reservation.
- 3. NSF CHECKS: All checks returned by the bank as insufficient, MUST be replaced with cash, money order or cashier's check, plus a \$25.00 service charge. If the payment was a futurity entry and the replacement money was not received by October 25<sup>th</sup> a late fee of \$100.00 will also be assessed. Any NSF not cleared up within ten days after the end of the show will result in immediate suspension from the SWRHA and the check will be turned over for appropriate action with the giver responsible for all additional costs incurred by the SWRHA.
- 4. MEMBERSHIP: Owner and riders must be current members, in good standing, of the NRHA. Current membership cards or a photocopy must be shown with each entry. Owners and riders must be members of the SWRHA to receive merchandise awards in each class.
- 5. NRHA COMPETITION LICENSE: All horses competing in NRHA classes must have an NRHA Competition License. The original or a photocopy MUST be shown with all entries. No transfers will be handled at the show. NEGATIVE COGGINS ARE REQUIRED.
- 6. PAYBACKS: Payback monies will be made according to NRHA payback schedule. Show retainage is 50%. All late fees and substitution fees will be added to the purse.
